## HEATHER GARDENS METROPOLITAN DISTRICT SPECIAL MEETING Friday, March 10, 2017 Amendment to the HGA/HGMD Management Agreement

The Special meeting of the Board of Directors of the Heather Gardens Metropolitan District was held in the office of the District, 2888 S. Heather Gardens Way, Arapahoe County, Colorado, on Friday, March 10, 2017.
